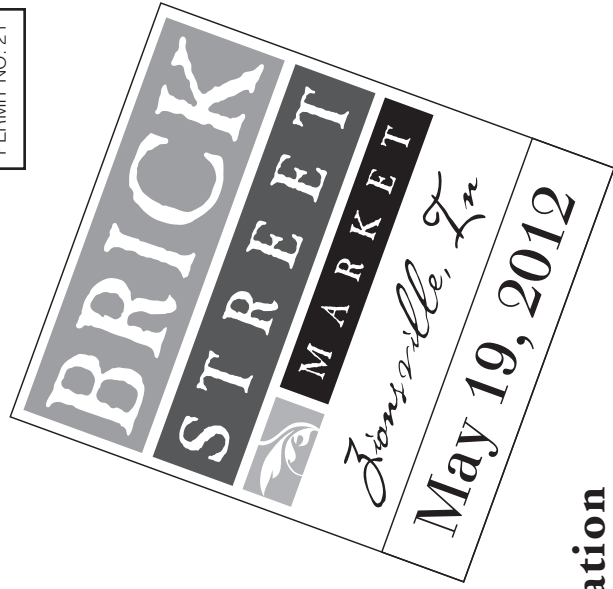

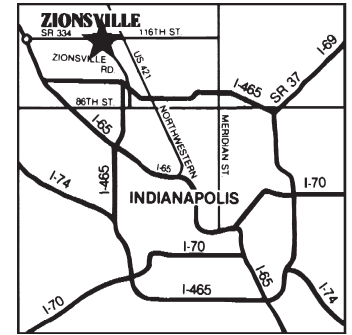

## EXHIBITOR INFORMATION

Prospective Exhibitor,

Exciting preparations are underway for the 27th annual Brick Street Market. This year the event will be held on Saturday, May 19, 2012, from 10:00 a.m. to 5:00 p.m. We invite you to submit an application for this long-standing arts and crafts tradition held on Zionsville's Main Street.

Each 10' wide by 8' deep booth space will be under tents and will rent for \$165.00. Exhibitors must provide their own display furniture, and please note, we do not provide electricity.

We ask that each application be accompanied by at least three (3) non-returnable photos to enable us to select the exhibitors. Any application submitted without pictures will not be considered. The quality of your pictures is important as they are the basis on which our selection committee will make it's decision. The pictures you submit must accurately depict what you will be selling.

Please return your completed application and \$165.00 payment by Friday, March 16, 2012. Applicants will be notified of their acceptance/denial by Friday, April 20, 2012. Please enclose a self-addressed stamped envelope for the acceptance/denial letter. Your self addressed envelope will be used to provide set up instructions and your event parking pass. All accepted exhibitors will receive a booth space/location assignment in their acceptance letter. The booth space assignments will not be based on prior year locations.

Each year we look forward to selecting from the diverse talent of our applicants. Those who will bring the highest quality of handcrafted and handmade products to the 2012 Brick Street Market will be selected. The selection committee will choose and approve from the following: antiques, art, food, green/organic products, photography, plants/flowers handmade and/ or handcrafted textiles. The committee will not accept mass produced, catalog or buy/sell products for our show and reserves the right to include or exclude exhibitors as deemed appropriate. We also reserve the right to not allow items to be sold at this event which were not shown in the representative photos submitted.
