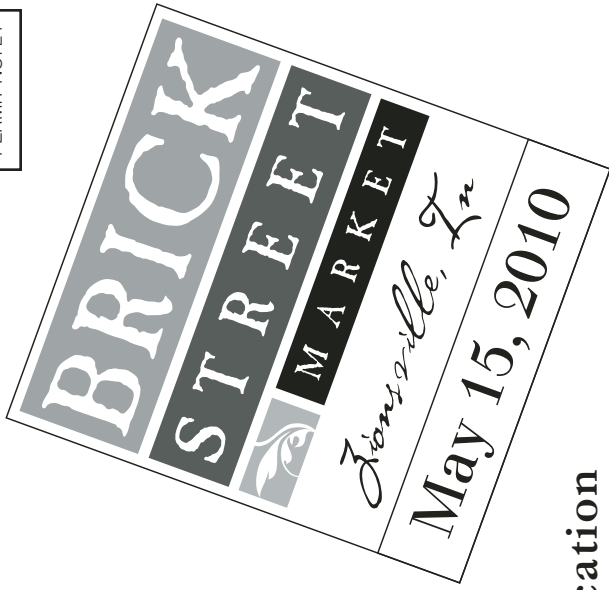

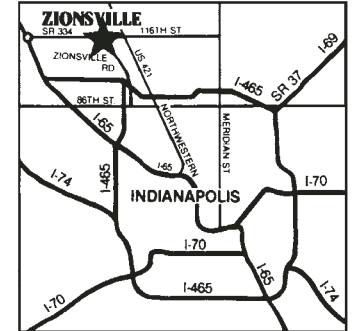

Prospective Exhibitor,

Plans are under way for our 25th annual Brick Street Market to be held Saturday, May 15, 2010 from 10:00 am to 5:00 pm. We invite you to consider participating in this spring tradition.

Each 10-foot wide by 8-foot deep booth space will be under tents and will rent for \$165.00. Exhibitors are to provide their own display furniture. We do not provide electricity.

We ask that each application be accompanied by at least three (3) non-returnable photos to enable us to select the participants. Any application submitted without pictures will not be considered. The quality of your pictures is very important as they are the basis on which the jury makes the decision.

Please return the attached application by Friday, February 26, 2010. The awarded participants will be notified of their selection by Friday, April 16th 2010. Enclose a self-addressed, stamped envelope for an acceptance or denial letter. (If you would like to have flyers, please enclose a self-addressed, stamped 9 x 12 envelope.)

Each year we look forward to our past applicants and welcome new entrants to bring the highest quality of arts, crafts, clothing and antiques to our show.

ENTRY DEADLINE: Friday, February 26,
2010. You will receive a confirmation letter
or your check returned by Friday, April 16,
2010. No refunds or cancellations.

DISPLAY SPACE: Booth spaces are 10' x 8' all
under tents. We do not provide electricity.

ENTRY FEE: \$165.00 No commission
will be charged.

NO RAIN DATE: However, all booths are under
white tents. If rain is forecasted, we recommend you
bring additional protection for your products.
